# Rules Of Order

- 1) Every sitting of the Meeting of the Association Body of Delegates shall be opened and closed with prayer.
- 2) Adequate time shall be allotted in the opening session for a devotional.
- 3) Persons invited to a seat may speak on all subjects under debate, but would have no vote.
- 4) Every speaker shall address the Chair and shall identify themselves and their Church.
- 5) No person shall speak for more than three minutes on any subject without permission of the Body.
- 6) No person shall speak more than twice on any subject without permission of the Body.
- 7) Motions made and lost shall not be recorded in the Minutes unless so ordered at the time. When the Motion is not recorded, the Minutes shall note the subject of the discussion.
- 8) The government of the Body and the regulations of its proceedings shall be strictly in accordance with parliamentary usage so called.
- 9) When a Church is received into the membership of the Association the Moderator shall give the "Right Hand of Fellowship" to one of its Delegates.
- 10) At the commencement of each session, except the first, the Minutes of the previous session shall be presented and approved, and the Minutes of the final session shall be approved by Council.
- 11) Resolutions shall be presented in writing when so desired by the Moderator or the Clerk.
- 12) Immediately after the opening of the Meeting these rules shall be distinctly read by the Clerk.

# HRUBA Executive Report

It has been a challenging year for all. We pray that all is well with you and your church family. After the Annual General Meeting for 2019 on March 7, 2020, Provincial Restrictions/Protocols were put into place because of a worldwide Pandemic, COVID-19, as you all know. It took a bit for us to get organized, as we are sure it did you, also. How do we continue to provide support and continue to make the changes needed, to move forward? God gave us, as Christians, a wonderful opportunity to meet the community around us, where they are. He has helped us with a new way to communicate and get our message out there. The use of social media and meeting platforms have become the normal now. We acquired a Zoom account for our meetings.

We are am so grateful to the Advisory Committee that you approved in 2018. They have been a blessing, as we work to streamline the Council; work out what you, the HRUBA family of churches, need and would like to see from us. We have had regular Executive/Advisory meetings through Zoom, to work on Constitutional changes, streamline the Council, and put together the AGM for 2020.

The Constitution Committee has, after much discussion with the Advisory team, come up with a streamlined Council and some By-law changes. Please read through the document sent to you.

The Nominating Committee was non-existent, so the Executive/Advisory team took on this role. April 2021 will see Ann step down as Moderator. Rev Dr Frank Guinta will take on this role for the next 2 years. Ann will step into the clerks' role for the next 2 years as we work to fill the positions that need to be filled. We will be looking for a clerk and a Vice Moderator. Because of the Pandemic, we have not attempted to fill any positions. As the Constitutional changes come into effect, the positions that need to be filled may change.

We are in the process of determining what we, as your Council, can do during this year and the Pandemic, to help you, HRUBA family of churches, sustain your ministry. At a Council retreat in September, we worked with Rev Garth Williams to try to determine our focus for 2021 and beyond. It was held at Bayside Camp with all the Provincial protocols in place. It was well attended with a couple of guests to help with the process.

As Ann passes the torch to Rev Dr Frank Guinta, she wants to say thank you for your continued prayers, support and faith in her over the past 5 years. It has been a privilege and an honour to serve you in this capacity. She asks you to focus your prayers and support on Frank, as he takes on this position, and the Council, as they seek to serve God and your needs in the coming days, weeks, months, and years.

# Halifax Baptist Chaplaincy Committee Report

—April 20, 2021 for the 2020 Fiscal Year

COVID-19 has had a dramatic effect on this ministry, which is perhaps best described by quoting from the Annual Reports submitted by our Chaplains.

From the Rev. Adele Crowell, “This year has proved to be one of challenge for many Nova Scotians and especially for all those who work in Health Care at the Nova Scotia Health Authority. Beginning in March, 2020 many changes and restrictions were placed on hospitals, and staff found themselves adjusting to new protocols week by week. We were delighted that Denominational Chaplains such as Rev. Ida and myself along with Roman Catholic, Anglican, and Presbyterian Chaplains were still welcome to visit patients in the hospital as we are considered an embedded part of the team. It fortified the reasoning as to why it is important for the Baptists to have Chaplains that are working within the hospital setting.”

“I received a number of calls from Pastors who were prevented from visiting, with referrals to church members who were in need of spiritual care. For a number of months, early on in the COVID-19 pandemic, family members were not allowed to visit. Later, that was changed to one support person and then later to two. Numerous patients remarked as to how important the Chaplain’s visits were to them especially being separated from friends and families. It was a busy time dealing with isolation, fear, anxiety and those patients who were feeling abandoned and depressed. During this year I was on half-time for six months but was still able to visit more than 900 patients predominantly in the Halifax Infirmiry.” Adele also continued to work with Clinical Pastoral Education students and to attend the Professional Advisory Council meetings.

From the Rev. Dr. Ida Armstrong-Whitehouse, “There was little indication that the world would go into crisis mode. In my 46 years of ministry, I have never seen a year like 2020. This year offered both obstacles and opportunities in Chaplaincy. For many Nova Scotians, our first inklings of COVID-19 were the global news of medical outbreaks around the world. Then came the Federal Government decision to mandate people who had been travelling outside Canada to self-isolate. That was the beginning.”

“Then, our HRM hospitals went into preparedness mode. Medical staff were set “on alert” to be front-line COVID-19 virus staff and some Hospital Units were set aside to deal with COVID-19 patients, if the need arose. Next, some medical staff were seconded to assist with the massive outbreak at Northwood. These factors all had a domino effect. This meant that our HRM hospitals were unable to carry on as usual, many elective surgeries were cancelled and there were less hospital beds and staff available. In the hospitals, a general NO VISITATION policy came into effect on March 16, 2020 which then meant a heavier workload for staff as visitors were no longer there to provide for non-essential care and comfort.”

However, this also provided an opportunity. Ida continued, “God had provided an open door for us. Adele and I were considered “*essential workers*” in most hospital units in the

health care system. It meant that we could continue to carry on our ministry at most of the hospital settings. Both staff and patients were appreciative of our presence and the ways that we were able to provide ministry during this time of stress and provide emotional and spiritual support. I was able to visit 630 patients this year. Families, friends and ministers made referrals to us through phone or emails. That was helpful.”

As the Halifax Baptist Hospital Chaplaincy Committee, we also had a lot of adjustments to make. We operated mostly with Zoom Meetings and emails. We also had to consider the health and safety of our Chaplains and their family needs in these uncertain times. In May, 2020, we amended our budget to account reduced expenditure due to Adele’s request for half-time service for six months beginning in April and some short periods of leave for Ida. We also anticipated a reduction in the ability of our partner congregations, associations and foundations to continue the level of financial support that we had come to rely on in the preceding years, and reduced the revenue projections in our budget as well.

About our Hospitals:

With Halifax hospitals acting as specialist resources to the whole of Atlantic Canada, there are people from all four provinces coming for treatment as well as those of us who live nearby. For people from “away”, the support of the chaplain is particularly important as they deal with strange surroundings—often without the support of family, friends, church visitors and their own pastor:

- The Halifax Infirmary Hospital.** This hospital site has three intensive care units and eight floors of inpatients dealing with all forms of trauma and focusing on specialties such as cardiovascular, orthopedics, neurology, burn treatments and plastic surgery.
- The Victoria General** site is home to the Palliative Care floor and treats many cancer patients both in outpatient clinics and as inpatients. Other specialties include ears, eyes, nose and throat, and bone marrow and stem cell transplants.
- The Nova Scotia Rehab Centre** provides rehabilitation services for many folks who have experienced strokes, neurological disorders and amputations.
- The IWK** is a hospital for women and children.

Financial Report: (2020 Budget and Actual and 2021 Budget)

As noted above, 2020 was a very unusual year for the Halifax Baptist Hospital Chaplaincy. We started the year with a budget that anticipated \$74,500 in revenue from local churches, the HRUBA, the Atlantic Baptist Foundation, and other donors, and with anticipated expenditures of \$74,469 for an essentially “balanced” budget. However, with the shutdown that came with COVID-19, we reduced our estimate of revenue by \$19,125 and with reduced staff hours, reduced our estimate of expenditures by \$16,718.


In October, we sent a letter to all the Nova Scotia churches of the Canadian Baptists of Atlantic Canada, communicating our reduced budget and service delivery and requesting their continued support for our ministry. The response from local churches in November and December was overwhelming and we have exceeded the level of support needed by our reduced 2020 operating budget, leaving us in a good starting place for 2021. Jenny did not plan on returning to the position of DAL Chaplain when she returned from her maternity leave. In August 2020 Lic. **Arla Johnson** from **FBCH** was recruited to undertake the role of DAL Chaplain because of the gap left by Rev. Jenny's departure. Arla is well experienced in personal counselling, in Baptist church services, preaching, visiting and working with congregants of all ages. Arla was more than willing to accept this position and felt blessed that she would be asked to assist in this very meaningful role.

COVID struck. It seemed little could be done. However, in August of 2020, Arla was introduced to Jordon Cameron in the DAL Interfaith Centre, by our HRUBA representative. From that introduction (done via email) Jordon and Arla consulted and exchanged necessary information. Arla sent her letter of recommendation from Senior Minister Rev. Rusty Edwards of FBCH, and her resume. Jordon was pleased and advised she would process Arla's information with the 'Student Life Director' at DAL. All was set.

Because of COVID there has been no opportunity for Arla to meet face-to-face with anyone at DAL. One task Arla was able to deliver on: The previous DAL Chaplain met weekly with the students, prepared and shared a meal. Arla developed a home video demonstrating how to cook a chicken meal! This video was supported by Robyn Brown-Howett (from **Dalhousie Multifaith Services**), who launched the video onto the DAL site! Another project that all the clergy from the various denominations of Dalhousie Multifaith Services participated in is the *Spiritual Wellness While in Quarantine – A Resource for Students*. Each clergy person was asked to write a reflection on a specific topic. Arla wrote her reflection on *Self-Isolating = Love*. All the reflections were collected and compiled into the spiritual wellness resource guide and distributed to students! A great and valuable project, appreciated by all!

# Bayside Camp and Retreat Centre Report

Report for HRUBA Spring 2021

It has certainly been a strange year out at the property of Bayside Camp. As we entered 2020, like the rest of the world, we imagined a regular year. We started with a few regular church retreats as well as our own annual Mens Retreat.

And you know the rest of the story. In March we were thrown into a different world. For camp this meant a season of constantly adapting and waiting. We threw out more draft ideas in three months than my previous 5 years as we tried to anticipate what the summer would look like and how we could best serve our community in the midst of a pandemic.

In the end our overnight season was completely cancelled along with our spring school group bookings and eventually our fall bookings as well. We hired 4 staff on grant positions to help navigate the summer and with their help launched Family Day programs in July and eventually brought an additional 6 staff and 15 volunteers on to host 3 weeks of day camps in August.

Through it all it was amazing to see the positivity from our staff and the new opportunities that a day camp program created. We were able to host an amazing group of staff who used their evenings to study God's word together and create a compassionate community.

In September Nathan Sullivan our Admin and Food Service Director moved on to a position at West End Church and Zack Davis our long time Program and Operations Director moved on in anticipation of a cross country move to B.C. It was our pleasure to serve along side them and we wish them the best!

This has been one of the hardest years of ministry as we tried hard to make the best decisions with very little available information. Through it all there have been many bumps and bruises, but God has been with us. What looked in the spring to be a very challenging financial year turned out only to be a modestly difficult financial year and we have seen God's hand in that.

In 2019 we entered an agreement with our loan holders the Atlantic Baptist Foundation to pay back our mortgage. This generous agreement includes a 10 year interest free window as well as a 5 year matching period by the ABF themselves! While 2020 put things on hold, we are excited to begin this campaign to secure a sustainable future for Bayside. If you are interested in joining the campaign team please contact me.

As we look to 2021 there are many unknowns but we are hoping and planning for a season of overnight camps and look forward to the story that God will continue to write through the ministry at Bayside. # HRUBA Home Missions Report

Over the past year the Missions Commission has been working with local congregations within our Association: to encourage and sustain vital aspects of local mission, ministry opportunities, and to help sustain church planting initiatives. In the context of the last two ministry grant cycles (The Atlantic Baptist Mission Board Ministry Grant and The HRUBA Ministry Grant 2020 and 20201) we have seen, through conversation with applicant churches, encouraged vision for ministry, training, and outreach. This you will hear from the following reviews:

Receiving the CBAC Home Mission Grant has assisted SCCC in the ongoing rebuilding of a church that had lost visibility and credibility. 2020 was a painful and challenging year. With God's help we came through stronger, better and more committed to Jesus Christ!

*Bring it 2021!* Rev. Pauline and Board of Directors SCCC. [Note: SCCC stands for Spryfield Christian Community Church]

The Grove Neighbourhood Church started gathering weekly on Sundays in the fall of 2018. We are 15 people currently, with 3-5 visitors regularly. Although our growth is small, yet it is tangible. For example, a family of 3 from China who arrived in Canada in 2019 came to faith in spring 2020. Also we ran two online Alpha courses in 2020 and had 5 guests. The second Alpha had people from 3 languages (English, Mandarin and Farsi), so we ran videos in all three languages. As it was for everyone, 2020 was a year of transitions, and at times we were discouraged to have to cancel many of our community-oriented activities. This new year we are establishing more solid theological roots by studying the Apostles Creed. We look forward to what God will do through us in 2021. We are grateful to HRUBA and ABMB for their grants in supporting our main church planter. Rev. Miro Rak, Pastor, on behalf of The Grove.

Our original grant request from HRUBA and the CBAC was to support Faith Baptist's establishment of a part-time children's ministry staff person to help us develop a high-quality children's ministry and engage in more community outreach to children and families. We began 2020 with a transition in our staff person employed in this role and an expansion of some of our children's ministry areas until everything was derailed by COVID-19. In May we were able to engage an ADC student, Erica Corbin, to serve in several pastoral support capacities, but particularly in coordinating our children's ministry. At that point this was largely an online effort. Later this position was key to partially re-establishing some of our in-person Sunday school alongside our video-based efforts to engage and support our younger families. We are thankful for the regular support from HRUBA Home Missions, and we have chosen not to seek additional grants going forward while we re-evaluate our efforts and priorities in the "new normal" that we hope will unfold in 2021. Rev Scot Borden, Pastor, on behalf of Faith Baptist Church.

Another aspect of the year has been following the progress with God's Army Community Fellowship (GACF), in Eastern Passage, as they continue with the application process towards acceptance in the HRUBA family as a member Church. Our involvement, with the Moderator, has been to track their progress, encourage, celebrate with, and offer

understanding in clarifying the process. This is a collaborative process with the Leadership of GAC and their Mentoring Church Team (West End Baptist).

We have deeply appreciated the warm collegiality of being co-workers in Christ with these hopeful forward-looking congregations and their leadership. In 2021 we are continuing to shape the task of the Missions Commission's mandate and prepare for the next cycle of ministry grant applications.

# Constitution Committee

—April 20, 2021 for the 2020 Fiscal Year

In 2020, the Constitution Committee continued the work started the year before at our Meeting of the Association Body of Delegates on March 23, 2019 to simplify the HRUBA organizational structure and the number of persons needing to be elected to leadership positions.

As discussions continued into 2020, they led to questions about whether the positions we were trying to fill were themselves part of the problem. The conclusion was that more streamlining was needed and the excessive responsibilities of some positions needed to be reduced. We recommended a number of structural changes, including eliminating the three District Representative positions, simplifying the role of Clerk, adding Program Coordinator to the role of the Vice Moderator, and adding a Communications Coordinator to oversee information dissemination to Member Churches and to coordinate with the Webmaster. Where something could be done by one person instead of a committee, it was decided to move in that direction (so “Coordinator” instead of “Committee”). Where it could be done by the Council Executive, rather than needing the whole Council, it was decided that fewer meetings for fewer people would be appropriate.

Discussions at the HRUBA Council Retreat on September 26, 2020 around issues such as diversity, inclusion, and social justice resulted in deciding it would be timely to establish up to two new “Member at Large” positions for the Council. These positions would not have a prescribed responsibility for any one Committee, Working Group or Ministry, but may be assigned to special projects or emerging needs or may represent a special interest or issue that Council wishes to pursue.

At the Council Meeting of November 12, 2020 it was agreed to circulate the draft to Member Churches for their review and comment in early 2021. A background document was prepared describing the process leading to the proposed changes and a table was prepared summarizing the proposed amendments with rationale or comment provided for each change. This whole package was also forwarded to our Communications Coordinator for posting on the HRUBA Website.

Following any Question and Answer sessions that may be requested by members, and any further consultation deemed necessary, it is intended that the amendments will be voted on at the April 20, 2021 Meeting of the Association Body of Delegates. A Notice of Motion was included in the information package.
